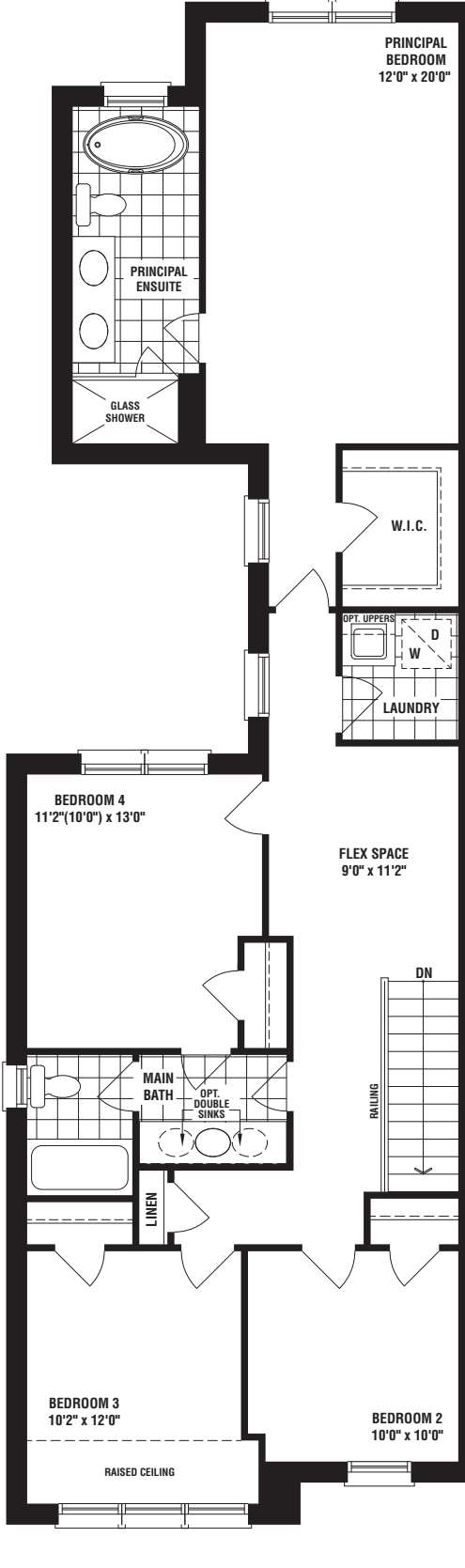

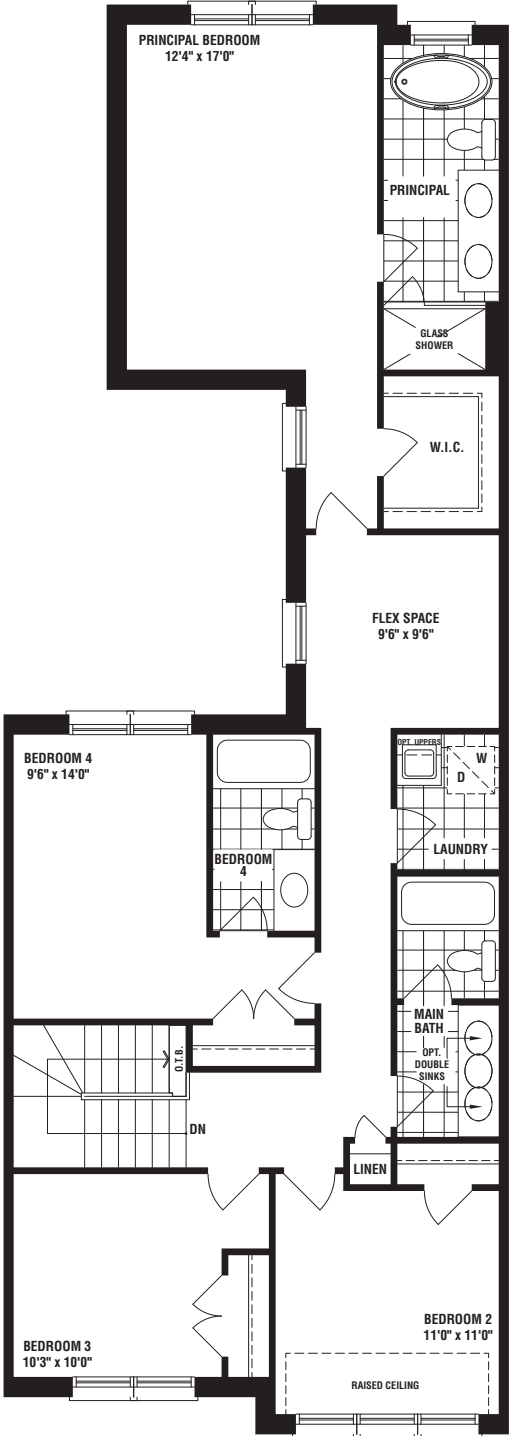

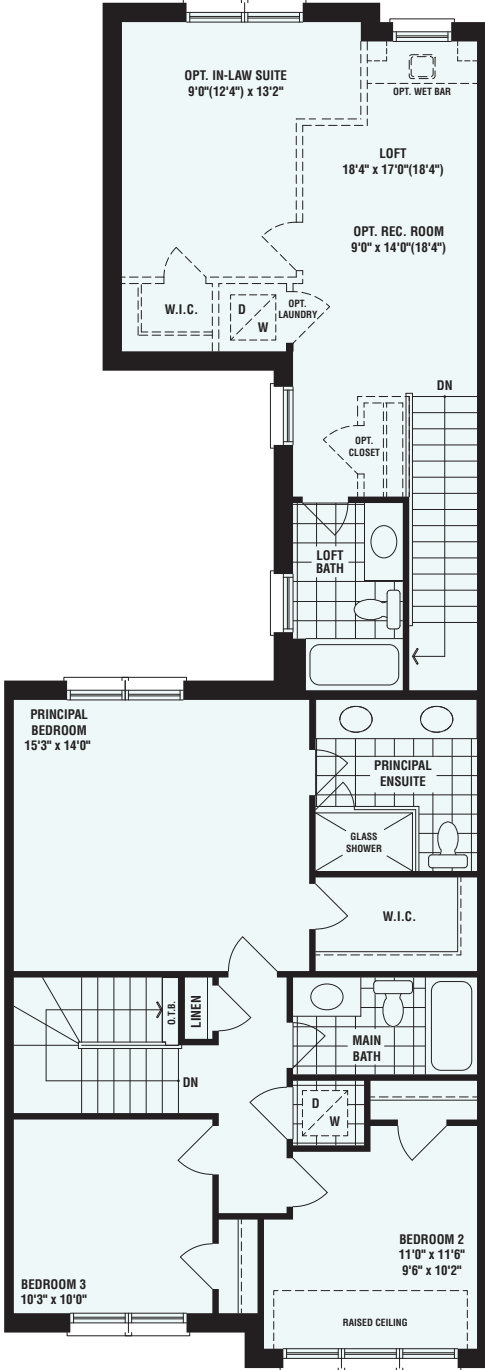
MAIN FLOOR W/ OPT. LOFT ELEV. A
